- 4 MS. LUCK: Good morning, Mr. Hearing Examiner --
- 5 sorry about that.
- 6 Kaitlyn Luck with the Santa Fe Office of
- 7 Holland and Hart on behalf of the applicant in these
- 8 cases, Catena Resources.
- 9 EXAMINER BRANCARD: All right. Any other
- 10 interested persons for Case 22137?
- 11 Hearing none, Ms. Luck you may proceed.
- I assume you're doing this by itself, you
- 13 are not combining it with the other cases. Is that

- 23 amend the Division's Order R-21433, which was previously
- 24 entered by the Division in Case No. 21351. This Order
- 25 approved a standard 640-acre spacing unit in the east half

of Sections 19 and 30. This is all in Township 18 South,

- 2 Range 25 East in Lea County, New Mexico.
- This Order approved a Wolfcamp spacing unit
- 4 and dedicated to the Rope 1H well. The details for that
- 5 well are provided in Catena's Exhibit A, which was filed
- 6 with the Division on Tuesday.
- 7 As reflected in Exhibit A, Catena is
- 8 seeking a one-year drilling extension in this case because
- 9 of the downturn during 2020 and Catena's change of
- 10 management, which has led to the Drill Schedule being
- 11 extended for this well.
- 12 So as you'll note in the affidavit, the
- drilling provision expired on August 18th of 2021 but our
- 14 application was filed before that, so Catena is now
- 15 seeking an extension until August 18th of 2022.
- And none of the parties that have been
- 17 pooled under this Order have been required to elect and
- 18 pay, and so that's why we are seeking to extend it at this
- 19 point.
- 20 So I would move the admission of Catena
- 21 Exhibits A, B and C and request that this case be taken
- 22 under advisement.
- 23 EXAMINER BRANCARD: Thank you. Mr. Simmons, any
- 24 questions?
- 25 EXAMINER SIMMONS: No, it appears to be in
