- 2 EXAMINER BRANCARD: With that I'm going to call
- 3 Items 31 through 34 on our worksheet. This would be Cases
- 4 22301, 22302, 22305, 22306, Matador Production Company.
- 5 MR. BRUCE: Mr. Examiner, Jim Bruce representing
- 6 the Applicant.
- 7 EXAMINER BRANCARD: All right. Are there any
- 8 other entries of appearances for Cases 22302, -302, -305,
- 9 -306?
- Hearing none, you may proceed, Mr. Bruce.
- MR. BRUCE: Mr. Examiner, in -301 and -302
- 12 Matador seeks to re-open Case 20904 to pool -- and -005, I
- 13 believe, to pool additional parties, collectively covering
- 14 the north half of Sections 21 and 22 of 20 South, 29 East.
- 15 Three additional parties were originally -- or a number of
- 16 parties, quite a few parties were originally pooled and
- 17 three more were located.
- That's pretty much it.
- 19 Exhibit 2 is the landman's affidavit
- 20 explaining the situation. And his -- he lists parties
- 21 being pooled who are brought in: Welch Kitto and OXY Y1
- 22 Company.
- 23 And since geology was previously presented
- 24 I'm not submitting a geologist's affidavit, and my
- 25 Affidavit of Notice showed that two of the three parties

1 received actual Certified Notice, but Ms. Kitto did not.

- 2 Or earlier this morning I was checking. I never did get
- 3 back anything, but I checked online with the U.S. Postal
- 4 Service and it says it was never picked up, so it's being
- 5 returned to my address.
- 6 Then there's an Affidavit of Publication.
- 7 And you will see that Affidavit of Publication -- although
- 8 I should say the first two cases involved the Bone Spring,
- 9 same thing; the second set of cases, -305 and -306 concern
- 10 the Wolfcamp Formation. And the Affidavit of Publication
- 11 you will see it covers additional cases to the ones we are
- 12 here for today, and those were voluntarily continued by
- 13 Matador.
- 14 Since the original Order was entered into,
- 15 these cases, the original cases had Pooling Checklists or
- 16 the equivalent, it used to be called Exhibit A, I did not
- 17 prepare new pooling checklists for these wells.
- 18 With that I would the move the admission of
- 19 Exhibits 1 through 4.
- 20 EXAMINER BRANCARD: Mr. McClure, any questions?
- 21 EXAMINER McCLURE: Yeah, just a quick one.
- 22 For Case 22306 it looks like we have two
- 23 exhibits submitted into the file. It looks like they are
- 24 identical. Is that the case?
- 25 MR. BRUCE: Uhm, two identical -- which

- 1 exhibits?
- 2 EXAMINER McCLURE: In the Case File 22306, you
- 3 got your exhibit packet submitted twice. I'm assuming
- 4 they are the same because they are the same size exactly
- 5 but I was just confirming that.
- 6 MR. BRUCE: Yeah, there is only one exhibit
- 7 package, so I don't know -- I was probably working too
- 8 late that night.
- 9 EXAMINER McCLURE: Okay. Sounds good. I was
- 10 just making sure there wasn't an updated version and one
- 11 of those is an older version or something like that. Very
- 12 good.
- MR. BRUCE: No, there is not.
- 14 EXAMINER McCLURE: Thank you. I don't have any
- 15 other questions.
- 16 EXAMINER BRANCARD: Thank you. Okay.
- 17 Mr. Bruce, there are three additional
- 18 interests you're trying to pool here; is that correct.
- 19 MR. BRUCE: That's correct.
- 20 EXAMINER BRANCARD: And two of them you were
- 21 able to contact?
- MR. BRUCE: Yes.
- 23 EXAMINER BRANCARD: And one you're relying on
- 24 the Affidavit of Notice Publication?
- MR. BRUCE: Yeah.

1 EXAMINER BRANCARD: It appears that the

- 2 publication is not timely. It's dated here October 23rd.
- 3 MR. BRUCE: Oh. Well, I can say I'm not the
- 4 only one today anyway. I sent this in days before that
- 5 and usually everything is timely.
- 6 You're right. Could I just have the
- 7 exhibits admitted and I'll continue the cases to the next
- 8 available hearing and just will allow the time to lapse,
- 9 or do you want me to republish Notice?
- 10 EXAMINER BRANCARD: No, I think it's fine. I
- 11 think we will just admit the exhibits here and then we can
- 12 continue this case to December 2nd to see if anybody else
- 13 jumped in.
- 14 MR. BRUCE: Okay. Thank you very much.
- 15 MR. BRANCARD: So again are there any other
- interested parties for Cases 22301, -302, -305, and -306
- 17 (Note: Pause.)
- 18 Hearing none, the exhibits in these cases
- 19 will be admitted into the record and these cases will be
- 20 continued to December 2nd to determine if any other
- 21 parties intervene in the case during that time period so
- 22 we have correct notice.
- MR. BRUCE: Thank you.
- 24 EXAMINER BRANCARD: Thank you.
