- 2 EXAMINER BRANCARD: With that I call Case No.
- 3 22381 Tap Rock Operating.
- 4 MS. SHAHEEN: Thank you, Mr. Examiner. Sharon
- 5 Shaheen of Montgomery & Andrews on behalf of Tap Rock
- 6 Operating.
- 7 EXAMINER BRANCARD: Are there any other
- 8 interested persons in Case 22381?
- 9 Hearing none, Ms. Shaheen you may proceed.
- 10 MS. SHAHEEN: Thank you. In this case Tap Rock
- 11 seeks to pool a 240-acre unit in the west half/west half
- 12 of Section 28 and the west half of the northwest quarter
- of Section 33, Township 24 South, Range 35 East for the
- 14 purpose of drilling the Coonskin Fee No. 111H.
- Tap Rock is only pooling one party, and
- 16 that is the New Mexico Department of Transportation.
- 17 Tap Rock believes that it has 100 percent
- 18 of working interest here, but apparently the Department of
- 19 Transportation believes it has an interest in the 1.9
- 20 acres of the drilling unit.
- 21 They are in the process of resolving that
- 22 title issue. Tap Rock has initiated a quiet title suit
- 23 and, in an abundance of caution, it went ahead and filed
- 24 this compulsory pooling proceeding.
- 25 If you take a look at the Table of

1 Contents, on .pdf page 2 you'll see that we have the usual

- 2 attachments: The checklist, the application, the landman
- 3 affidavit with the usual exhibits, the geologist affidavit
- 4 with the geologist's usual exhibits. Both the landman and
- 5 the geologist have previously testified before the
- 6 Division and had their credentials accepted.
- 7 Also you will find the Affidavit of Notice
- 8 indicating that the Certified Mailing was received by the
- 9 Department of Transportation.
- 10 Unless anyone has some questions, I would
- 11 ask that the Division take Case No. 22381 under advisement
- 12 and admit all of the exhibits that have been submitted.
- 13 EXAMINER BRANCARD: Thank you.
- 14 Mr. Garcia.
- 15 EXAMINER GARCIA: No questions.
- 16 EXAMINER BRANCARD: All right. So we get
- 17 questions when there are other state agencies involved, so
- 18 has Tap Rock been in communication with DOT?
- MS. SHAHEEN: My understanding is they have
- 20 been. DOT received a Well Proposal as well as the Notice
- 21 Letter with respect to the application.
- They haven't had recent communications, I
- 23 believe, since the quiet title lawsuit was filed.
- 24 We've attached the Complaint as Exhibit 6
- 25 to the landman's affidavit, so that gives quite a bit of

- 1 detail about the history behind the quiet title issue. I
- 2 didn't look at it in detail but my understanding was there
- 3 was a previous quiet title lawsuit that Tap Rock was
- 4 relying on, and I believe the Department of Transportation
- 5 has asserted that it was not a party to the previous quiet
- 6 title.
- 7 But that's my very basic fundamental
- 8 elementary understanding of that complaint. Cavin &
- 9 Ingram represents Tap Rock in the quiet title lawsuit.
- 10 EXAMINER BRANCARD: So my understanding, reading
- 11 the Complaint, it's an issue about the mineral rights.
- MS. SHAHEEN: That's right.
- 13 EXAMINER BRANCARD: You're obviously not
- 14 claiming the highway.
- 15 MS. SHAHEEN: That's right. We are not claiming
- 16 anything other than the minerals underlying the 1.9 acre
- 17 tract that the Department of Transportation is claiming.
- 18 At least that's my understanding. It's
- 19 only about the minerals. I can't imagine that Tap Rock
- 20 would care about anything else.
- 21 EXAMINER BRANCARD: I did see the note in here
- 22 in the exhibits that there were also royalty interests
- 23 with this tract, but you're not pooling them.
- 24 MS. SHAHEEN: My understanding, and this goes
- 25 back to some previous cases before the Division, my

Page 7 understanding -- oh, it looks like there are some 1 2 overriding royalty interests, and then it says that the final interest is subject to Division Order and title 3 verification. 5 But we are not seeking to pool those overrides at this time. We are only seeking to pool the 6 Department of Transportation. 8 EXAMINER BRANCARD. Okay. You might be back? MS. SHAHEEN: I suppose it's possible. 9 EXAMINER BRANCARD: All right. Thank you. 10 11 Anything? Any follow-up, Mr. Garcia? 12 EXAMINER GARCIA: No, thank you. 13 EXAMINER BRANCARD: Are there any other interested persons in Case 22381? 14 15 Hearing none, this case will be taken under 16 advisement. 17 MS.
