1 HEARING EXAMINER BRANCARD: Mr. Rankin, are you
2 doing the next few cases?

3 MR. RANKIN: Mr. Examiner, depending on whether
4 you have questions, I don't have my materials in front of
5 me, but those next series of cases have been continued for
6 the same reasons as the previous cases.

7 HEARING EXAMINER BRANCARD: My records show we
8 did these cases one by one, but I guess we could possibly do
9 them as a group here right now since it's the same issue.

10 So I will call Case Numbers 22466, 22467, 22468,
11 22469, 22470 and 22471, Spur Energy Partners.

12 MR. RANKIN: Mr. Examiner, Adam Rankin with the
13 Santa Fe office of Holland & Hart appearing on behalf of the
14 the applicant in each of these cases.

15 HEARING EXAMINER BRANCARD: Thank you. And these
16 cases were all continued from the last hearing due to the
17 need for the notice time frame to run. Is that correct?

18 MR. RANKIN: That's correct, Mr. Examiner. In
19 each of these cases the notice of publication was published
20 several days late on account of the newspaper being unable
21 to accommodate our requests that they be published within a
22 certain time frame, so these cases were each continued in
23 order to ensure that notice was properly perfected for
24 publication.

25 In addition, Mr. Examiner, we filed a revised

1 exhibit in the Oasis Case, that is case 22466, which
2 correctly reflects that notice was provided by certified
3 mail to each of the parties, and that was filed of record
4 with the Division, and we ask that that revised exhibit be
5 accepted as a matter of record in that case.

6 With that exception, no other exhibits or
7 revisions were required for these cases, and we ask that in
8 light of the fact that no other parties have entered an
9 appearance or appeared this morning, that these cases be
10 taken under advisement.

11 HEARING EXAMINER BRANCARD: Thank you. That's
12 the only case I see a filing in is 22466, and that revised
13 exhibit will be taken into the record. But once again I
14 will ask, are there any other parties for Cases 22466, 467,
15 468, 469, 470 and 471.

18 Lowe do you have questions?

19 TECHNICAL EXAMINER LOWE: No, I do not.

20 HEARING EXAMINER BRANCARD: Thank you. With

22 22471 will be taken under advisement. Thank you.
