2 EXAMINER BRANCARD: With that, I call Case 22631,
3 Catena Resources Operating.

4 MS. McLEAN: That is me as well, Mr. Examiner,
5 Jackie McLean, of Hinkle Shanor, on behalf of Catena
6 Resources.

7 EXAMINER BRANCARD: Thank you. COG Operating?

8 MS. RYAN: Yes, Beth Ryan again for COG Operating.

9 EXAMINER BRANCARD: Ms. Ryan, do you have any
10 objection to this case going forward by affidavit?

11 MS. RYAN: No, sir.

12 EXAMINER BRANCARD: Thank you. Any other
13 interested persons in Case 22631? Hearing none, please
14 proceed, Ms. McLean.

15 MS. McLEAN: Thank you. In Case Number 22631, we
16 seek to pool all uncommitted interests in Wolfcamp formation
17 underlying a 320-acre standard horizontal spacing unit
18 comprised of the E/2 W/2 of Sections 5 and 8, Township 19
19 South, Range 35 East, in Lea County, New Mexico. The
20 spacing unit will be dedicated to the Rocky E2W2 05 08 W1 1H
21 well, which will be horizontally drilled from a surface
22 location in SE/4 SW/4 Unit N of Section 32, to a bottom hole
23 location in the SE/4 SW/4 of Unit N of Section 8.

24 And the exhibit packets that were submitted to the
25 Division contain Exhibit A, which is the land professional's

1 testimony and related land exhibits, which include the plot
2 of tracts, ownership interest, pooled parties, a well
3 proposal letter, and a summary of communications.
4 Exhibit B, which is a self-affirmed statement of the
5 geologist Catherine Henry, and Ms. Henry was just admitted
6 previously to testify before the OCD, but, you know, we
7 didn't know which order these cases were going to be taken,
8 so we've also included her resume as Exhibit B1 in this
9 packet, and we've also included a location map, structure
10 map, gun barrel schematic and a cross-section of the
11 intervals and interest, and then geology exhibits. Then
12 finally, Exhibit C is a notice affidavit, which sets out
13 when the notice letter of this hearing and application were
14 sent to COG, and we went a little overboard and also
15 published in the Carlsbad paper on March 13th, and a copy of
16 the affidavit of publication is attached as Exhibit C3.

17 And with that, I'd ask that Exhibits A, B and C be
18 admitted into the record in Case Number 22631, and that Case
19 Number 22631 be taken under advisement.

20 EXAMINER BRANCARD: Thank you.

21 Ms. Ryan, any questions?

22 MS. RYAN: No, sir. Thank you.

23 EXAMINER BRANCARD: All right.

24 Mr. McClure?

25 TECHNICAL EXAMINER McCLURE: And, Mr. Brancard, I

1 have no questions here either.

2 EXAMINER BRANCARD: Thank you. All right. So,
3 Ms. McLean, it looks like COG is the only party to be pooled
4 in this case?

5 MS. McLEAN: That's correct.

6 EXAMINER BRANCARD: Thank you. All right. I have
7 no further questions. Are there any other interested
8 persons, then, for Case 22631? Hearing none, the exhibits
9 will be admitted into the record and Case 22631 will be
10 taken under advisement.

11 MS. McLEAN: Thank you, Mr. Examiner.
