7 Mewbourne.

9 Production Company?

11 Santa Fe office of Holland & Hart on behalf of Matador and
12 MRC Permian.

13 HEARING EXAMINER BRANCARD: Thank you. EOG
14 Resources Inc.?

15 MR. PARROT: Good morning. This is James Parrot
16 with Beatty & Wozniak representing EOG.

17 HEARING EXAMINER BRANCARD: Thank you. All
18 right. Let's start with Mr. Bruce. Where are we on these
19 cases?

20 MR. BRUCE: Mr. Examiner, I'm not quite sure.
21 The parties have been in discussions regarding this group of
22 cases, and at this point we need -- we need to continue
23 them. Maybe Mr. -- excuse me, my throat is going on me --
24 perhaps Mr. Feldewert can fill in more. Obviously I
25 personally need a continuance of these because if the

1 parties don't settle, I will have to step aside from
2 representing Mewbourne. So that's about all I know.

3 HEARING EXAMINER BRANCARD: Thank you. Mr.
4 Feldewert?

5 MR. FELDEWERT: Yeah, Mr. Examiner, the parties
6 are in discussions about the development plans. It's my
7 understanding that those discussions have been active. They
8 are also trying to sort through some title issues associated
9 with the acreage. I have been requested or asked to request
10 another status conference in two months to allow the parties
11 to walk through these issues.

12 MR. BRUCE: That would be acceptable to me, Mr.
13 Examiner.

14 HEARING EXAMINER BRANCARD: Mr. Parrot, any
15 comments.

16 MR. PARROT: No objection.

17 HEARING EXAMINER BRANCARD: So two months from
18 now would be July 21. Hearing no grumbling --

19 MR. FELDEWERT: That will work, Mr. Examiner.

20 HEARING EXAMINER BRANCARD: We will issue a
21 scheduling order.

22 MR. BRUCE: Thank you.
