16 again, Ms. Vance.

17 MS. VANCE: Thank you.

18 HEARING EXAMINER BRANCARD: I have an entry from
19 ConocoPhillips and Burlington Oil & Gas Company.

20 MS. RYAN: Beth Ryan appearing for ConocoPhillips
21 and Burlington Oil & Gas Company.

22 HEARING EXAMINER BRANCARD: My understanding we
23 are here because ConocoPhillips, et al, is objecting to the
24 case moving forward by affidavit.

25 MS. RYAN: That's correct.

1 HEARING EXAMINER BRANCARD: So we would like to
2 set this -- well, let me start with asking Ms. Ryan, is
3 Conoco et al intending on presenting additional cases?

4 MS. RYAN: No, sir, not at this time. We are
5 continuing to work through the JOA with Matador, and so we
6 like, you know, this to be set in June or July. It could be
7 resolved by then.

8 HEARING EXAMINER BRANCARD: All right. But you
9 would like to set for a hearing.

10 MS. RYAN: Sure. That's fine with us.

11 HEARING EXAMINER BRANCARD: Mr. Rankin, Ms.
12 Vance?

13 MS. VANCE: No objection from Matador.

14 HEARING EXAMINER BRANCARD: All right. Well,
15 let's set this then for a hearing July 7.

16 MS. RYAN: Thank you, Mr. Examiner.

17 HEARING EXAMINER BRANCARD: We will issue a
18 prehearing order.

19 MS. VANCE: Thank you, Mr. Examiner.

20 MR. BRUCE: Mr. Examiner, this is Jim Bruce. I
21 think you skipped over Cases 14 through 17 on the docket.

22 HEARING EXAMINER BRANCARD: I thought they were
23 all part of prior cases I had listed in the -- of prior
24 cases.

25 MR. BRUCE: If that's the case, that's fine.

1 I've got so many cases pending, I don't remember the acreage
2 anymore.

3 HEARING EXAMINER BRANCARD: Yeah, I think they
4 are -- Mr. Feldewert, correct me, but I think there are two
5 sets of Matador, two sets of Mewbourne cases and one set of
6 Matador cases.

7 MR. BRUCE: Okay.

8 MR. FELDEWERT: That's correct. Jim, these are
9 the ones that you filed after the Pretty Bird, but they
10 also -- Travesty and Thunderbolt.

11 MR. BRUCE: Oh, okay, thanks.

12 HEARING EXAMINER BRANCARD: Thank you.
