- 2 With that, we're on Item 60, Case 22823 Steward
- 3 Energy.
- 4 TECHNICAL HEARING OFFICER GARCIA: Jackie
- 5 McLean with Hinkle Shanor on behalf of Steward
- 6 Energy.
- 7 HEARING OFFICER BRANCARD: Are there any
- 8 other interested persons for Case 22823?
- 9 Hearing none, you may proceed, Ms. McLean.
- MS. McLEAN: Thank you.
- In Case Number 22823 Steward seeks to pool
- 12 one additional interest owner under Order
- 13 Number R-22051.
- On February 23rd, 2022, the Division
- 15 entered Order R-22051 in Case Number 22476, which
- 16 pooled all uncommitted interest in the San Andres
- 17 South pool underlying a 320-acre, more or less,
- 18 standard horizontal spacing unit comprised of the
- 19 west half of Section 15, Township 13 South, Range 38
- 20 East, Lea County, New Mexico.
- 21 The order dedicated the unit to the Huell
- 22 Fee Number 5H well and designated Steward as the
- 23 operator of the unit and well.
- And after the entry of the order, Steward
- 25 identified one mineral interest owner whose interest

1 should be pooled under the order. And if you look

- 2 at Exhibit A5, which is the chronology of contract,
- 3 chronology of contacts, I'm sorry, you'll see that
- 4 that one, and see that what needs to be pooled under
- 5 the existing order is Suzanne Davis, LP which owns
- 6 3.51 percent of an unleased mineral interest within
- 7 the unit.
- And on December 12, 2022 the Suzanne
- 9 Davis, LP oil and gas lease expired and Steward has
- 10 attempted to reach an agreement since the expiration
- 11 of the oil and gas lease. And this is all set out
- 12 in Exhibit A5, which is attached to the land
- 13 professional's testimony.
- 14 And Suzanne Davis did receive a well
- 15 proposal letter, AFE and timely notice of the
- 16 hearing. And the exhibit packet submitted to the
- 17 Division for Case Number 22823 contains Exhibit A,
- 18 which is the land professional's testimony and
- 19 related land exhibits, which include the order that
- 20 Steward is seeking to reopen, the plotted tracts,
- 21 ownership interest, and the additional uncommitted
- 22 interest to be pooled under the terms of the order
- 23 as well as the well proposal letter to Suzanne
- 24 Davis, LP and the summary of communications, which I
- 25 mentioned earlier.

1 And then Exhibit B is a notice affidavit

- 2 which sets out when the notice letter was sent out,
- 3 and applications were sent to Suzanne Davis, LP.
- 4 We received a signed green card back,
- 5 which is Exhibit B2, but it was not dated. And then
- 6 we also went ahead and published in the Hobbs New
- 7 Sun on May 10, 2022.
- 8 And with that, I ask that Exhibits A and B
- 9 be admitted into the record in Case Number 22823 and
- 10 that Case Number 22823 be taken under advisement.
- 11 HEARING OFFICER BRANCARD: Thank you.
- 12 Mr. Garcia, any questions?
- 13 TECHNICAL HEARING EXAMINER GARCIA: I have
- 14 no questions.
- 15 HEARING OFFICER BRANCARD: I don't have
- 16 any questions either.

- 19 Hearing none, the exhibits will be
- 20 admitted into the record and Case 22823 will be
- 21 taken under advisement.
