1 HEARING EXAMINER BRANCARD: With that, we go to
2 Case 22833, Colgate Operating.

3 MS. HARDY: Thank you. Dana Hardy on behalf of
4 Colgate.

5 HEARING EXAMINER BRANCARD: Any other interested
6 persons for Case 22833?

7 (No audible response.)

8 HEARING EXAMINER BRANCARD: Hearing none, please
9 proceed.

10 MS. HARDY: Thank you. In this case Colgate
11 seeks to pool additional uncommitted interests under Order
12 R-21355-A. The Division entered that order on September 25
13 of 2020. In Case 21227, the order pooled uncommitted
14 interests in the Bone Spring underlying the N/2 of Sections
15 33 and 34, Township 19 South, Range 28 East.

16 The order dedicated the unit to the Shamrock 34
17 Fed State Com 121H, 131H, 122H and 132H wells. After the
18 order was entered, Colgate identified additional parties who
19 needed to be pooled.

20 The exhibits that we provided include the
21 landman's affidavit, which is Exhibit A, the related land
22 exhibits that include a plat of the tracts and ownership
23 interest to be pooled. That information is in Exhibit A-3.
24 In Exhibit A-5 is a contact chronology that discusses the
25 efforts to locate the parties including those who are

1 unlocatable.

2 Exhibit B is my notice affidavit which provides
3 the dates on which notice was sent. We've included a chart
4 that shows when parties were notified, and we provided the
5 certified mail receipts. We have also included an affidavit
6 of publication which was timely published in June.

7 With that, unless there are questions, I ask that
8 Exhibits A and B be admitted into the record and the case be
9 taken under advisement.

10 HEARING EXAMINER BRANCARD: Thank you. Mr.
11 McClure, questions?

12 TECHNICAL EXAMINER McCLURE: No questions,
13 Mr. Brancard.

14 HEARING EXAMINER BRANCARD: Thank you. Once
