I.

INTRODUCTION AND SUMMARY

Burnett Oil Co., Inc. ("Burnett"), and Hudson Oil Company of Texas ("Hudson"), herein sometimes are jointly called "Applicants", appear through their undersigned attorneys and hereby make application to the Division for an order: (1) consolidating and expanding the existing Glorieta-Yeso Oil Pools described below; (2) establishing special rules and regulations for the consolidated and expanded Yeso Pool; (3) cancelling, in whole or in part, or, alternatively, providing a method for makeup of prior overproduction by all operators in the consolidated pool; and (4) consolidating this application with the application of Concho Operating, LLC ("Concho") in OCD Case No. 14613, and in support thereof show as follows:

II. APPLICATION

- 1. Burnett and Hudson are operators in or have applied for permits to drill wells in one or more of the following pools, or lands adjacent or nearby:
 - a. The Cedar Lake Glorieta-Yeso Pool, which was created by Division Order

No. R-11067, dated November 1, 1998 and currently covers the following lands:

2. The development and spacing of these pools are now governed by the Division's statewide rules. Division Rule 19.15.15.9 NMAC provides that a well within a defined oil pool shall be located on a spacing unit consisting of 40 acres and located no closer than 330 feet to a boundary of the unit.

3. Division Rules 19.15.20.12 NMAC and 19.15.20.13 NMAC provide that pools have a depth bracket allowable of 80 barrels of oil a day for the Loco Hills

Glorieta-Yeso Pool, and either 80 or 107 barrels of oil a day for the other pools, with a limiting gas-oil ratio ("GOR") of 2000:1.

4. Burnett and Hudson requests that:

(a) The Division order that the above described pools be consolidated as a single pool; and

(b) The Division expand the consolidated pool to include additional adjacent lands so that the pool as consolidated and expanded will include the lands and have the horizontal extent described on <u>Exhibit A</u> hereto; and

(c) The Division establish a vertical interval of the consolidated pool to be defined as from the top of the Glorieta formation, as found at a drilled depth of 4,210 feet in the Burnett Oil Co., Inc. Gissler B #67 Well (located 2,310 feet FSL and 430 feet FEL, Sec. 8, T17S, R30E, Eddy County, New Mexico), as shown on the Halliburton Induction Electric Log of such well, through the top of the Tubb member of the Yeso formation, as found at the drilled depth of 5,825 feet as shown on the same electric log, and intervals correlative thereto, in all wells in the consolidated pool; and

(d) The Division enact special rules and regulations for the consolidated pool to provide for (i) a depth bracket allowable of 240 barrels of oil a day and a limiting gasoil ratio ("GOR") of 2500 SCF:1 BO, or such greater or lesser allowable or GOR as the evidence may show to be necessary to prevent waste and protect correlative rights; (ii) a special additional allowable of capacity for both oil and gas for newly completed wells to be defined as from first production until a well recovers a volume of water equal to 110% of the water injected into the pool during hydraulic fracturing for completion until the end

of the third calendar month following such time; (iii) a density rule of two wells per 40 acre spacing/proration unit with all wells that have been drilled or spudded on or before the effective date of the Final Order in this application being "grandfathered" to produce lawfully within the special rules for the pool; and (iv) a balancing rule for overproduction to allow operators to balance over and under production of oil and gas from each unit in the pool, calculated on a unit basis, within each calendar year.

(e) The Division order that all past overproduction in the consolidated pool of all operators either be cancelled ratably based on their allowables; or, alternatively, be made up within the twenty-four (24) months next following the entry of the Final Order herein; order that overproduction be defined as production of gas in excess of the gas allowable for a spacing unit, and production of oil in excess of the lesser of either (i) for units producing at a GOR equal to or less than the pool's limiting GOR, the oil allowable for the unit or (ii) for units producing at a GOR greater than the pool's limiting GOR, the amount of oil calculated by multiplying the oil allowable by a fraction, the numerator of which is the GOR for the unit, and the denomination of which is the unit's actual producing GOR. For example, if a unit's oil allowable is 240 barrels per day, and the limiting GOR is 2,500:1, but the unit produces at a GOR of 6,000:1, then its oil allowable would be 100 barrels of oil per day calculated as follows: 240 x 2,500/6,000 = 100.

(f) All other rules for the consolidated pool to be in conformance with statewide rules.

5. The granting of this application is in the interests of conservation, the prevention of waste and the protection of correlative rights.

III. MOTION FOR CONSOLIDATION

Applicants hereby move that this application be consolidated with the application of Concho in OCD Case No. 14613 insofar as the Concho application covers the six existing pools identified herein, and the additional lands within the consolidated pool, as described on Exhibit A hereto. Both applications include common issues of law and fact; consequently, judicial economy and the interests of conservation of oil and gas require a single hearing, and a uniform and consistent resolution of these common issues by a Final Order in a consolidated case.

IV. NOTICE

Notice of this application has been given to all Division designated operators in the affected pools, and of wells within the same formation as such pools within one mile of the pools' outer boundaries as shown as Exhibit B hereto.

V. PRAYER

WHEREFORE, Burnett Oil Co., Inc. and Hudson Oil Company of Texas request that this application be consolidated with Concho's application in OCD Case No. 14613, now set for hearing at 9 am on May 16, 2011 and be heard at the same time in a consolidated case; that notice be given as required by law and the rules of the Division; and, that this application be approved.
