Mike Pippin sent a revised AOR list with TD's and cement tops. I also searched for all wells drilled to the target depths and within ½ mile of any of the 10 proposed injection wells.

Anyway, the attached list has 7 wells to be investigated a bit further.

The three red wells may be uncemented over the proposed 2400 to 3400 feet injection interval, but if Mike will look at them again and if possible send wellbore diagrams?

The four blue wells appeared in my list but not in Mike's. The Tigner St #2 is likely undeterminable (like OCD rules...). Please look at the last three wells to see if cement tops cover the injection interval – send diagrams if not too much trouble.
