1. I am competent to make this affidavit.
2. I was attorney of record for COG Operating, LLC, in the captioned proceeding before an examiner of the Oil Conservation Division (Division) resulting in issuance of Division Order R-10067-B.
3. At the Division hearing I presented the Affidavit of Service prepared by J. Scott Hall, Esq. of Montgomery & Andrew, P.A., who filed the application on behalf of COG Operating, LLC and sought to send notice, in accordance with the procedural requirements of the Division, to all interest owners and operators affected by the application.
4. At the hearing, I requested and was granted leave to supplement the record with U.S. Postal Service return receipts sent by Mr. Hall to Anadarko Petroleum Corp. and Tandem Energy Corp.
5. The Tandem Energy Corp. return receipt was not later received by Mr. Hall, nor could delivery of the Tandem Energy notice at its last known address in Midland, Texas, be effected.
6. Through efforts of David Evans of COG Operating LLC and my prior efforts to locate Tandem Energy Corp. in Midland in an other unrelated Division case, we


discovered that Tandem Energy Corp. had been merged with Platinum Energy Resources in Houston, Texas.

7. I then initiated contact, both telephonically and email, with Stephen Fuerst and T. Nguwen concerning the purpose of the hearing. Through email I sent them a copy of the application and the pre-hearing statement prepared by Mr. Hall. I also forwarded to them, through email, their request for information on the location of Platinum Energy Resources' closest well. Copies of pertinent email communications with Mr. Fuerst and Mr. Nguwen and myself are attached hereto.

8. At some point in the dialogue between Mr. Fuerst and Mr. Nguwen and me I recommended to COG Operating LLC that Mr. Ramon Reyes, the geologist employed by COG Operating, LLC, to directly communicate with Mr. Nguwen with regard to any further specific concerns that Platinum Energy Resources may have had. To my knowledge there was direct communication between Mr. Reyes and Mr. Nguwen.



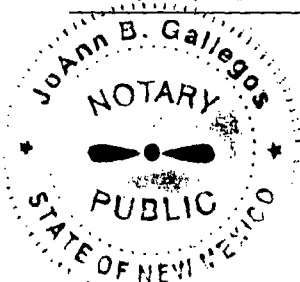

Gentlemen:

Attached are the application and pre-hearing statement that I mentioned during our earlier telephone conversation. Briefly, the application calls for the vertical extension of the Grayburg-Jackson (Seven Rivers-Queen-Grayburg-San Andres) Pool to correspond with the horizontal and vertical extent of the Burch-Keeley Unit in Eddy County, NM, operated by COG Operating. The application and the pre-hearing statement are self-explanatory as to the purpose of the application. The 5000-feet of vertical depth is based on ownership (rather than geologic features) which was severed by Conoco, quite some time ago, thus creating an allocation of production problem should the pool be extended beyond 5000 feet. Conoco owns the rights below 5000 feet.

As I explained during our conversation, an attempt to notify Tandem Energy, an offset operator or owner, of a January 6, 2011 hearing was ineffective due to the fact that Tandem has merged with Platinum and is no longer in Midland. At the hearing we disclosed that the certified mailing to Tandem had been ineffective, therefore, my purpose in contacting you is to seek a waiver of the application and hearing. This would eliminate the necessity of having to continue the hearing and send notice by certified mail of the hearing of at least 20 days.

In the meantime I have asked COG Operating for information concerning your nearest well or interests. As soon as I get that I will forward it to you.
