1           MADAM CHAIR: Good morning. This is the meeting of  
2 the Oil Conservation Commission on September 22, 2011, here  
3 in Porter Hall in Santa Fe. I'm Jami Bailey, chairman of the  
4 Commission. To my right is Scott Dawson, designee of the  
5 Commission of Public Lands. To my left is Bob Balch,  
6 designee of the Secretary of Energy, Minerals and Natural  
7 Resources. To his left is Mark Smith, who is the Commission  
8 counsel today. And then court reporter, Irene, and to the  
9 far right is for Floreen Davidson, the Commission Clerk.

10           We do have a quorum. We have all three  
11 Commissioners in attendance today. Commissioners, have you  
12 had a chance to read the minutes of the previous meeting in  
13 August?

14           COMMISSIONER BALCH: Yes.

15           COMMISSIONERS DAWSON: I have.

16           MADAM CHAIR: Is there a motion to adopt --

17           COMMISSIONER DAWSON: I motion.

18           MADAM CHAIR: -- the minutes of that meeting?

19           COMMISSIONER BALCH: I will second.

20           MADAM CHAIR: Okay. I will sign it on behalf of the

3 extension of the Grayburg-Jackson, (Seven Rivers-Queen-  
4 Grayburg-San Andres) Pool to correspond with the Unitized  
5 Formation of the Burch Keely Unit in Eddy County, New Mexico?

6 COMMISSIONER DAWSON: I have.

7 COMMISSIONER BALCH: I have.

8 MADAM CHAIR: Is there a motion to adopt this order?

9 COMMISSIONER DAWSON: Yes. I make that motion.

10 MADAM CHAIR: Is there a second?

11 COMMISSIONER BALCH: I will second.

2 Marshall and Winston Incorporated to cancel an operator's  
3 authority, and terminate a spacing unit, and approve a change  
4 of operator in Lea County, New Mexico, that case has been  
5 continued to the December 8 Commission meeting.

6 Case ~~14720~~ which is the application of Agave Energy  
7 Company for authority to inject in Lea County, New Mexico,  
8 has also been continued to the December 8, 2011, Commission  
9 meeting.
