APPLICATION

Cimarex Energy Co. applies for an order (i) approving a non-standard oil spacing and proration unit in the Bone Spring formation comprised of the W¹/₂E¹/₂ of Section 16, Township 21 South, Range 34 East, N.M.P.M., Lea County, New Mexico, and (ii) pooling all mineral interests in the Bone Spring formation underlying the non-standard unit, and in support thereof, states:

1. Applicant is an interest owner in the $W\frac{1}{2}E\frac{1}{2}$ of Section 16, and has the right to drill a well thereon.

2. Applicant proposes to drill its Berry 16 State Com. Well No. 1 to a depth sufficient to test the Bone Spring formation. Applicant seeks to dedicate the $W\frac{1}{2}E\frac{1}{2}$ of Section 16 to the well to form a non-standard 160.00 acre oil spacing and proration unit (project area), for any formations and/or pools developed on 40 acre spacing within that vertical extent. The well is a horizontal well, with a surface location in the SW $\frac{1}{4}SE\frac{1}{4}$, and a terminus in the NW $\frac{1}{4}NE\frac{1}{4}$, of Section 16.

3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the $W_{2}^{1/2}E_{2}^{1/2}$ of Section 16 for the purposes set forth herein.

4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests.

Therefore, applicant seeks an order pooling all mineral interest owners in the $W^{1/2}E^{1/2}$ of Section 16, pursuant to NMSA 1978 §§70-2-17,18.

5. The approval of the non-standard unit and the pooling of all mineral interests underlying the $W^{1/2}E^{1/2}$ of Section 16 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

A. Approving a non-standard oil spacing and protation unit (project area) in the Bone Spring formation comprised of the $W^{1/2}E^{1/2}$ of Section 16;

B. Pooling all mineral interests in the $W^{1/2}E^{1/2}$ of Section 16 in the Bone Spring formation;

C. Naming applicant as operator of the well;

D. Considering the cost of drilling and completing the well, and allocating the cost among the well's working interest owners;

E. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and

F. Setting a 200% charge for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well.
