#### ORDER OF THE COMMISSION


This matter comes before the Oil Conservation Commission ("Commission") on a January 26, 2012 letter ("Letter") from James Bruce, attorney for Burnett Oil Company, Inc. ("BOC") and Hudson Oil Company of Texas ("HOC"). The Letter is approved by Michael B. Campbell, attorney for BOC and HOC; Michael H. Feldewert and Adam Rankin, attorneys for COG Operating LLC ("COG") and Premier Oil & Gas, Inc.; and John R. Cooney and Earl E. DeBrine, Jr., attorneys for Apache Corporation.

The Letter represents that "the parties" request that Case Nos. 14613 and 14647 regarding Order No. R-13382-E; Case Nos. 14640 and 14641 regarding Order No. R-13450; and Case Nos. 14673, 14674, and 14706-14718 regarding Order No. R-13481 (the "Cases"), which currently are set for hearing on February 23, 2012, be continued to the next available Commission docket. The letter further reports that BOC, HOC and COG are engaged in discussing and finalizing a settlement that would resolve all matters in the Cases.

The Commission will treat the Letter as a motion. There being no opposition to the motion, the Commission finds that it is well taken and should be granted.

**NOW THEREFORE** the motion is **GRANTED** and each of the Cases is continued to the next meeting of the Commission following the February 23, 2012 meeting, which currently is scheduled for **March 27, 2012**.
