16 dismissed, case 14775 continued to February 16th. The
17 next two cases we'll hear. Case number ~~14763~~ has been
18 continued to January 5th. Case number 14629 continued
19 to February 2nd, 2012.

20 That leaves us, according to my count, with four
21 cases. Everybody agree with that? Super.
