Dear Working Interest Owner:

Cimarex Energy Co. ("Cimarex") hereby proposes to drill the Independence 8 Federal Com No. 2 (the "Well") at a legal location in the S/2NE/4 of Section 8, and the S/2 of Section 9, Township 15 South, Range 31 East, N.M.P.M., Chaves County, New Mexico.

The intended surface hole location for the Well is 1830' FNL & 2310' FEL of Section 8 and the intended bottom hole location is 1980' FNL & 330' FEL of Section 9. The Well is proposed to be drilled vertically to a depth of approximately 9,100' to the lower Abo/Wolfcamp formation and laterally in a Easterly direction within the formation to the referenced bottom hole location. Total measured depth of the Well is proposed to be approximately 15,766' from surface to terminus.

It should be understood that compliance with topography or cultural or environmental concerns, among others, might require modification of Cimarex's intended procedure. Cimarex will advise you of any such modifications.

Enclosed, in duplicate, is (i) our detailed AFE reflecting estimated costs associated with this proposal, and; (ii) our proposed form of Operating Agreement to govern operations of the Well. If you intend to participate, please approve and return one (1) original of the enclosed AFE and one (1) original of the signature page to the Operating Agreement, along with the contact information to receive your well data, to the undersigned within thirty (30) days of receipt of this proposal. If you elect to purchase your own well control insurance, you must provide a certificate of such insurance to Cimarex prior to commencement of drilling operations; otherwise, you will be covered by insurance procured by Cimarex and will be responsible for your share of the cost.

In the event you do not wish to participate in drilling the Well, Cimarex will consider acquiring a term assignment of your leasehold interests in the N/2 of Section 9 based on the following general terms:
