1 MR. EXAMINER: Good morning, everybody. 2 This hearing will come to order. We're going to go into 3 the docket. I want to make a brief announcement for the 4 general consumption. Take a seat, take a seat.

As you all know, we have a new rule and it's in 5 effect now and there are certain implementations that we 6 7 need to make sure that you understand. From now on whenever you are presenting an interval well, you know, 8 something like from that kind of a case, I would 9. 10 appreciate it if you could give us the well construction 11 diagram at the hearing so that we know where the 12 completed interval is at.

As you all know, a completed interval is a new term where we implemented a new rule. It's not just for this area. Therefore, you can present the well any way you want it as long as you give us the construction and tell us where the completed interval is. That would be really appreciated.

Most of the cases we have today, the information is for that area and the drilling of the well. And you may not have that well complete and you may submit after the hearing. But I want you to do it to make sure that you present the well construction in the area and not after the fact.

Page 3 be subject to interpretation. Here we have a technical 1 2 examiner to help you; Mr. Brooks is here. And we can also help you with any technical interpretation that you 3 may have in trying to comply with that rule or trying to 4 present your case before the OCD or the OCC, whatever 5 the case may be. So if you need any interpretation 6 please let us know. We did one on Monday, and we would 7 appreciate it if you understand how they can implement 8 the project. I really liked it. We are working with 9 10 you.

11 Okay. And I want to remind everybody, I have a 12 full house today, about the new policy that was put in 13 place just this February about this issue of continuing 14 applications and the cases dismissed without prejudice. 15 So I want to make sure everybody understands that some 16 of the cases stay on the docket for years and then it's 17 crossed off the docket.

And the recommended decision is that we need to 18 continue for only three times or four times and then it 19 has to be heard or dismissed without prejudice. 20 So I want to make sure -- I think I told you that we 21 22 grandfathered any continuances before February 2nd. So if you are continued for 10 times or 20, it didn't 23 So whenever you think your case has been 24 count. continued for three times, please make sure you prepare 25

to get it heard or dismiss it yourselves or we will
dismiss it for you without prejudice.

You know, I talked about an example that I see of 3 what is going on in the field about operations, how 4 negotiations are going on. I see one thing placed on 5 you, the fact that we would like you to, you know, 6 7 negotiate. So coming to the hearing and if you actually come to the hearing, because you have the right. Of 8 course you have the right to come to a hearing. Nobody 9 is saying don't come to the hearing. 10

But in the interest of similar processes I would 11 appreciate it if you guys can try to negotiate. 12 And 13 when it's broken down in negotiations come to the 14 hearing. Not everything is coming to the hearing and 15 then the docket is closed out that we are -- you know, we have short staff. We don't have enough to deal with 16 17 every process of the case that you may have that could have been settled if you negotiate the case. 18 So I 19 always talk about this. And I think it helps you so 20 much if you bring it to the hearing, we decide it, and you may not like it. So I encourage you to negotiate 21 22 among yourselves.

Now I wanted to say, are there any questions or comments? Anything that anybody can do or any questions that we can handle? Okay, then we're going to call today's docket.
Today is April 26th and we're going to call Docket
Number 13-12. And first order of business is to call
the dismissals and continuances.

5 On page 1, case 14657 is dismissed. On page 2, 6 case number 14814 is continued to May 10th. Then go to 7 page 4, case number 14810 is dismissed. All the cases 8 from case number 14819 up to 14824, all those cases are 9 continued to May 10th; 14819, 14820, 14821, 14822, 14823 10 and 14824 are all continued to May 10th.

11 On page 5, case number 14825 is continued to May 10th. Case number 14826 is continued to May 10th. 12 13 Case number 14828 is dismissed. Page 6, case number 14 14829 is dismissed. Case number 14830 is dismissed. On 15 page 7, case number 14687 will be dismissed without prejudice. And I want to read this out for the record 16 to tell you what I just said about continuing for three 17 18 times and then four times they continue the hearing. So 19 it had to be dismissed without prejudice.

Let me read it into the record, the case that will be dismissed without prejudice. This is application of Cimarex Energy Company for a non-standard oil spacing and proration unit and compulsory pooling for, Chaves County, New Mexico will be dismissed without prejudice.
