APPLICANT'S STATEMENT OF CASE

COG Operating LLC seeks an order: (1) creating a non-standard, 160-acre spacing and proration unit comprised of the E/2 W/2 of Section 9, Township 19 South, Range 26 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Glorieta-Yeso formation underlying this acreage. This proposed non-standard spacing and proration unit will be the project area for the Stonewall 9 Fee No. 2H well to be horizontally drilled from a surface

location 150 feet from the North line and 1700 feet from the West line (Unit C) to a bottom hole location 330 feet from the South line and 1700 feet from the West line (Unit N) of Section 9. The completed interval for this well will remain within the 330-foot standard offset required by Division rules.


