

1. I am a landman for applicant Yates Petroleum Corporation ("Yates"). I have personal knowledge of the matters stated herein.

2. Yates' application seeks an order approving an 80-acre non-standard oil spacing and proration unit ("80-acre unit") in the Salt Lake-Delaware formation in the SE/4 NW/4 and NE/4 SW/4 of Section 14, Township 20 South, Range 32 East, NMPM, in Lea County. A C-102 Well Location and Acreage Dedication Plat identifying the proposed 80-acre unit is attached hereto as Exhibit A.

3. The proposed 80-acre unit is to be dedicated to the Belco "AIA" Federal No. 6 well, a directional well to be drilled at a surface location 2,010 feet from the South line and 2,010 feet from the East line, with a terminus location 1,980 feet from the South line and 1,980 feet from the West line.




