

### NOTICE

To: Bernard Jones, and James K. Lusk and Martha L. Lusk, Trustees of the James K. Lusk and Martha L. Lusk Trust (U/A dated April 29, 1992) or their successors, heirs, or devisees: Mewbourne Oil Company has filed an application with the New Mexico Oil Conservation Division seeking an order approving a 158.39-acre non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of Lot 4 SE/4SW/4 and S/2SE/4 (the S/2S/2) of Section 30, Township 18 South, Range 30 East, NMPM, Eddy County, New Mexico. Applicant further

seeks the pooling of all mineral interests in the Bone Spring formation underlying the S/2S/2 of Section 30 to form a non-standard 158.39-acre oil spacing and proration unit (project area). for all pools or formations developed on 40 or 80-acre spacing within that vertical extent. The units are to be dedicated to the Bradley 30 Fed. Well No. 2, a horizontal well with a surface location in the SE/4SE/4 and a terminus in the SW/4SW/4 of Section 30. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The application is scheduled to be heard at 8:15 a.m. on Thursday, March 29, 2012 at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505. As an interest owner in the well unit, you have the right to enter an appearance and participate in the case. Failure to appear will preclude you from contesting this matter at a later date. The attorney for applicant is James Bruce, P.O. Box 1056, Santa Fe, New Mexico 87504. The unit is located approximately 7 1/2 miles south of Loco Hills, New Mexico.
