**APPLICANT'S STATEMENT OF CASE**

COG Operating LLC seeks an order (1) creating a non-standard 160-acre spacing and proration unit comprised of the W/2 E/2 of Section 2, Township 19 South, Range 26 East,

NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Yeso formation underlying this acreage to form a 160-acre project area in this formation. COG proposes to dedicate the above-referenced spacing and proration unit as the project area for its proposed Grant 2 Fee 3H Well (API #30-015-39587), to be horizontally drilled from a surface location 330 feet from the South line and 1910 feet from the East line (Unit O) to a bottom hole location 330 feet from the North line and 2260 feet from the East line (Lot 2) of Section 2.


