October 5, 2011	Sent letter notifying all interested parties of our intention to downhole commingle the Mesaverde/Mancos/ and Dakota formations in the San Juan 29-5 Unit # 77M well.
October 20, 2011	Madalyn Joy Johnson responds advising she objects. No reason just objects.
October 2011	Attempted to reach by phone and left a message to call me back.
November 2011	Attempted to reach by phone and left a message to call me back.
November 5, 2011	After repeated unsuccessful attempts to reach by phone sent a letter by Certified Mail explaining why we want to commingle and how her interest might be impacted. Delivery of the letter was attempted on November 22, 2011, November 29, 2011, and December 8, 2011, and finally returned to us "Unclaimed".
December 9, 2011	Re-sent letter by regular mail.
December 2011	Attempted to reach by phone and left a message to call me back.
January 11, 2012	Attempted to reach by phone and left a message to call me back.
January 11, 2012	Madalyn Joy Johnson returned my call and advised she had given my letter to her attorney.
February 2, 2012	Attempted to reach by phone and left a message to call me back.
February 2, 2012	Her attorney Mr. Clyde F. Worthen contacted me by phone and I explained why we want to commingle and how his client's interest might be impacted.
February 3, 2012	Attempted to reach by phone and left a message to call me back.
February 8, 2012	Attempted to reach by phone and left a message to call me back.
February 14, 2012	Sent an E-mail to Mr. Clyde F. Worthen explaining commingling and it's possible impact on his client.
February 14, 2012	Mr. Clyde F. Worthen responded advising he would review and get back to me.
February 22, 2012	Sent an E-mail to Mr. Clyde F. Worthen asking if he had questions.
February 22, 2012	Mr. Clyde F. Worthen responded by E-mail advising he had discussed with Madalyn Joy Johnson and he had further questions.

February 22, 2012	Sent an E-mail to Mr. Clyde F. Worthen responding to his questions.
February 28, 2012	Mr. Clyde F. Worthen called and left a message that he had another question.
February 29, 2012	I spoke with Mr. Worthen answered his question and he advised he would recommend his client withdraw her objection.
March 26, 2012	Sent e-mail to Mr. Worthen telling we want to proceed and asking if his client will be withdrawing her objection.
March 26, 2012	Mr. Clyde F. Worthen responded by E-mail advising he had recommended his client withdraw her objection several weeks before and asked me to contact her directly.
March 27, 2012	Attempted to reach by phone and left a message to call me back.
March 27, 2012	Engaged Tom Kellahin to direct legal effort for approval to downhole coming through the NMOCD.
April 2012	Attempted to reach by phone and left a message to call me back.
April 2, 2012	Madalyn Joy Johnson sends an E-mail thanking me for the information and advising she is still reviewing.
April 3, 2012	Sent e-mail to Madalyn Joy Johnson advising we are requesting a hearing before the NMOCD, again asking her to withdraw her objection and reiterating I would be happy to try and answer any questions she might have.
April 11, 2012	Hearing advertised as required by the Rules.
April 2012	Attempted to reach by phone and left a message to call me back.
May 4, 2012	Madalyn Joy Johnson sends an E-mail with a withdrawal of her objection but states she is doing it under duress.
May 4, 2012	We ask her for clarification of what she means by "under duress".
May 5, 2012	Attempted to reach by phone and left a message to call me back.
