APPLICANT'S STATEMENT OF CASE

COG Operating LLC seeks an order (1) creating a non-standard 160-acre spacing and proration unit comprised of the S/2 N/2 of Section 28, Township 23 South, Range 28 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Bone Spring

formation underlying this acreage to form a 160-acre project area in this formation. COG proposes to dedicate the above-referenced spacing and proration unit as the project area for its proposed Falcon 28 1H Well (API #30-015-37000), to be horizontally drilled from a surface location 1980 feet from the North line and 530 feet from the East line (Unit H) of Section 28 to a bottom hole location 1980 feet from the North line and 350 feet from the West line (Unit E) of Section 28. The completed interval for this well will be within the 330-foot standard offset required by the rules.
