STATEMENT OF THE CASE

APPLICANT

OPPONENT

Applicant requests approval of a severely unorthodox oil well location for a well it has already drilled. Devon objects to approval of the location, for the following reasons:

1. The well will drain offsetting leases owned by Devon.
2. Applicant's well is on state land, while Devon's offsetting leases are federal land. If the location is approved Devon may be subject to a development demand by the

Bureau of Land Management. However, Devon has no plans to drill an offset well at this time and thus would incur liability, at a minimum, in the payment of compensating royalties.

Devon requests that the application be denied.


