This letter is to advise you that Legacy Reserves Operating LP has filed the enclosed application with the New Mexico Oil Conservation Division seeking authority to inject for purposes of salt water disposal into Andrew Arnquist Estate No. 2 Well, at a surface location 330 feet from the North line and 330 feet from the East line of Section 29, Township 18 South, Range 26 East, N.M.P.M., Eddy County, New Mexico, into the Cisco Canyon formation at a depth of approximately 7,750 feet to 8,100 feet. Said well is located approximately 1.5 miles southwest of Dayton, New Mexico. A copy of the Oil Conservation Division Form C-108 is enclosed for your information.

This application has been set for hearing before a Division Examiner at 8:15 a.m. on April 26, 2012. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. 
