Ladies and Gentlemen:

Mewbourne Oil Company ("Mewbourne") as Operator is interested in drilling multiple horizontal wells under the captioned land for Delaware and Bone Spring oil production. The initial well will be drilled at a surface location 185' FNL & 2150' FWL of the captioned Section 35 and will be drilled horizontally to a bottom hole location 330' FSL & 2150' FWL of the captioned Section 35 to a true vertical depth of 6,700 feet beneath the surface to evaluate the middle Avalon (Bone Spring) Shale for oil and gas production. The proposed well will be drilled laterally to a measured depth of approximately 11,075 feet.

Regarding the above, you will recall that Mewbourne Oil Company as Operator previously drilled its Layla "35" Fee Com No. 1 Well at a location 1650' FSL & 1241' FEL of the captioned Section 35, which well was completed as a commercial gas well on February 8, 2003 producing from the Atoka formation. 
Dear Mrs. Osborn:
