COG Operating LLC ("COG") (OGRID No. 229137) hereby seeks administrative approval pursuant to the provisions of Division Rule 19.15.15.13 NMAC for an unorthodox well location for its Patton 5 Fee No. 4H well in Section 5, Township 19 South, Range 26 East, N.M.P.M., Eddy County, New Mexico. As drilled, the well has a surface location 2310 feet from the North line and 235 feet from the West line of said Section 5.

The well was originally planned as a horizontal well targeting the Yeso formation, Atoka; Glorieta-Yeso Pool, but the lateral had to be abandoned. COG now proposes to complete up hole in the vertical portion of the well bore within the Grayburg-San Andres formation, Dayton; West San Andres Pool. A completed interval in that location will result in an unorthodox well location requiring Division approval.

Exhibit A is a land plat for Section 5 and surrounding sections that shows the as-drilled, non-standard location of the Patton 5 Fee No. 4H well in relation to adjoining units. This location is unorthodox because the Dayton; West San Andres Pool under this acreage is governed by the Division's statewide rules which provide for wells on 40-acre spacing units to be located no closer than 330 feet to the outer boundary of the spacing unit. As drilled, this location is 235 feet from the West line of said Section 5. As a result, the proposed completed interval will be closer to the western boundary of the section line than allowed by Division rules.

Exhibit B is the Well Location and Acreage Dedication Plat (Form C-102), which shows that the Patton 5 Fee No. 4H well encroaches on the spacing and proration unit to the West.

Here, a portion of the completed interval encroaches to the West upon Cimarex Energy Company's unit. The affected party, therefore, is Cimarex Energy Company. A copy of this application with all attachments was mailed to the notice recipient. Because COG anticipates the Cimarex Energy Company will protest this application, COG has filed an application for a hearing in this matter for the September 20 hearing docket.

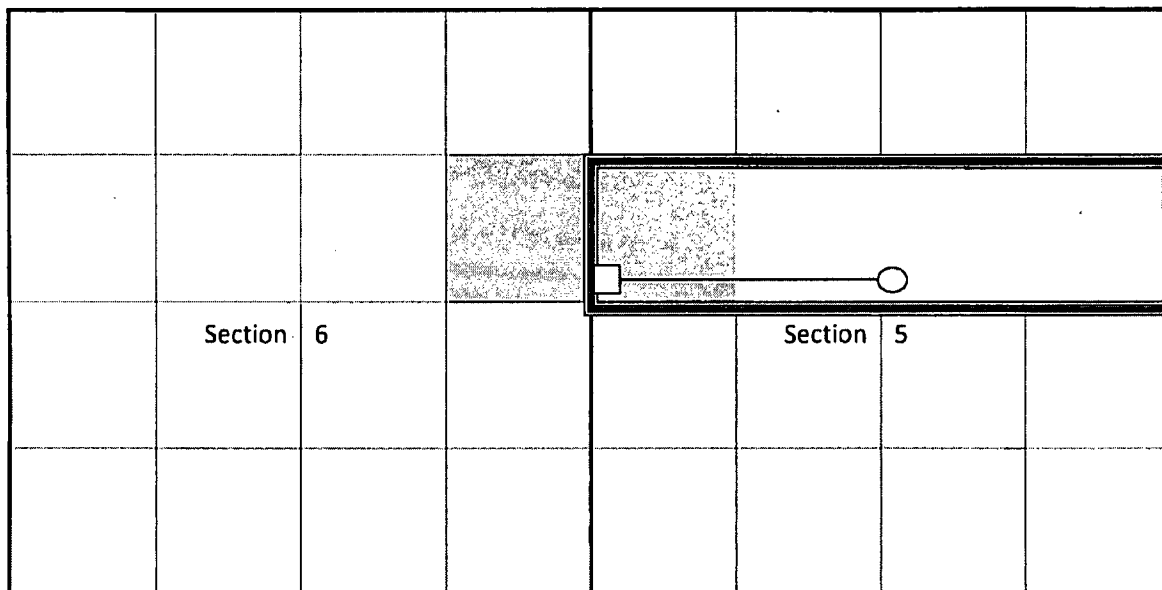

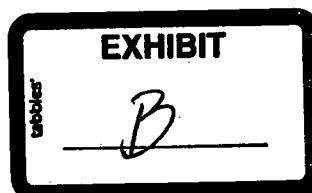


