THE APPLICATION OF THE OIL CONSERVATION DIVISION FOR AN ORDER CREATING, RECLASSIFYING, REDESIGNATING AND EXTENDING HORIZONTAL LIMITS OF CERTAIN POOLS IN CHAVES, LEA AND ROOSEVELT COUNTIES, NEW MEXICO.

### ORDER OF THE DIVISION

#### BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on September 6, 2012, at Santa Fe, New Mexico, before Examiner Richard I. Ezeanyim.

NOW, on this 10<sup>th</sup> day of September, 2012, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

#### FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the San Andres formation, bearing the designation of North Anderson Ranch-San Andres Gas Pool (Pool Code: 97679). The North Anderson Ranch-San Andres Gas Pool was discovered by the Mack Energy Corporation Granite State Well No. 1 (API No. 30-025-29036), located in Lot 8 of Section 2, Township 16 South, Range 32 East, NMPM, which was completed in the San Andres formation on February 6, 2008. The top of the perforations is at 4,598 feet.
- (3) There is need for the creation of a new pool in Roosevelt County, New Mexico for the production of oil from the Upper Pennsylvanian formation, bearing the designation of North Bluitt-Upper Pennsylvanian Pool (Pool Code: 97734). The North Bluitt-Upper Pennsylvanian Pool was discovered by the H L Brown Operating LLC. Federal 27 Well No. 1 (API No. 30-041-20818), located in Unit E of Section 27,

Township 7 South, Range 37 East, NMPM, which was completed in the Upper Pennsylvanian formation on November 14, 2008. The top of the perforations is at 8,548 feet.

The North Cooper-Morrow Gas Pool was discovered by the Lone Star Oil & Gas, Inc. Pevehouse 8 Well No. 1 (**API No. 30-025-38571**), located in Unit P of Section 8, Township 24 South, Range 36 East, NMPM, which was completed in the Morrow formation on June 20, 2008. The top of the perforations is at 12,556 feet.
- (7) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the Abo formation, bearing the designation of North Hightower-Abo Gas Pool (**Pool Code: 97659**). The top of the perforations is at 8,528 feet.

The South House-San Andres Pool was discovered by the Chesapeake Operating, Inc. The top of the perforations is at 4,326 feet.
- (9) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Mississippian formation, bearing the designation of

Jenkins-Mississippian Pool (**Pool Code: 97676**). The Jenkins-Mississippian Pool was discovered by the Yates Petroleum Corporation Vince BGH Well No. 1 (**API No. 30-025-37104**), located in Unit J of Section 30, Township 9 South, Range 35 East, NMPM, which was completed in the Mississippian formation on February 1, 2008. The top of the perforations is at 12,534 feet.

- (10) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Upper Bone Spring Shale formation, bearing the designation of Jennings-Upper Bone Spring Shale Pool (Pool Code: 97838). 
#### IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for

spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations, reclassifications, redesignations and extensions of horizontal limits included herein shall be October 1, 2012.
