Dear Mr. Brooks:

I acknowledge the August 30, 2012 communication from Mr. Timothy Evans (Holland & Knight) on behalf of the Jicarilla Apache Nation advising of the likely need to obtain a continuance of the September 20, 2012 hearing in Case No. 14904. Presumably, because of the commonality of certain issues with those in Case No. 14548, the Nation's pending request would include that case, as well.

On behalf of Heritage Petroleum, Inc. this will advise that we will agree to a continuance. In the next few days, we will confer with counsel for the Nation to establish a new date for the hearing and hope to advise you of the same before Docket No. 31-12 is called next week. I also suggest that it would be appropriate to convene a pre-hearing conference to discuss the best means for advancing these cases toward disposition. For now, I will hold in abeyance the filing of a pre-hearing statement or a response to the Nation's Motion to Dismiss until these interim discussions take place.
