Please refer to my letter dated February 8, 2012 proposing the captioned well, which contained errors in the location description. Please disregard such letter and replace it with the following revised proposal.

According to the records of Lea County, New Mexico, you own an interest in a certain oil and gas lease covering a portion of the lands comprising the spacing/drilling unit for the subject well. Nearburg Exploration Company, L.L.C. also owns oil and gas leases covering a portion of such lands, and believes it is in the best interest of all parties to cooperate in developing such lands and the corresponding leases. Accordingly, Nearburg hereby proposes the drilling of the captioned horizontal well to test the 3rd Bone Spring formation at the above surface location (SHL), with the horizontal portion of the well drilled due West at a TVD of ± 11,150° to the captioned terminus (EOL), with a TMD of ± 15,900°, which will create a drilling/spacing unit consisting of the W/2W/2 of said Section 23. I have attached for your review an AFE for the proposed well.

In addition, Nearburg proposes the formation of a working interest unit covering of the W/2 of Section 23, T-20-S, R-34-E, N.M.P.M.. In connection with such proposed working interest unit and upon your election to participate in the drilling of the proposed well, I will provide for your review and your execution a 1982 AAPL Form operating agreement naming Nearburg Producing Company as the operator. A full description of the oil and gas leases and the contractual interests that would be owned by each party under this proposal will be shown on Exhibit "A" to such operating agreement.
