APPLICATION

YATES PETROLEUM CORPORATION ("Yates"), through its undersigned attorneys, hereby makes application for an order approving its Chicken Little State Exploratory Unit and in support of this application states:

1. The proposed Unit Area consists of 3323.16 acres, more or less, of State of New Mexico and Fee lands, situated in Chaves and Lea Counties, New Mexico. The horizontal limits of said unit are described as follows:

Township 10 South, Range 31 East, N.M.P.M.

Section 24: All
Section 25: All
Section 35: NE/4, S/2 NW/4, SW/4, SE/4
Section 36: All

Township 11 South, Range 32 East, N.M.P.M.

Irregular Section 4: Lots 3, 4, S/2 SW/4 (All)
Irregular Section 5: Lots 1, 2, 3, 4, S/2 S/2 (All)
Irregular Section 6: Lots 1, 2, 3, 4, 5, SE/4 SW/4, S/2 SE/4 (All)

2. The Unit Agreement has been approved by a sufficient percentage of the interest owners within the proposed Unit Area to provide effective control of unit operations.

3. The Applicant, Yates Petroleum Corporation, is designated as Unit Operator in said Unit Agreement and all oil and gas in all formations are unitized.


4. The proposed Unit Area covers all, or substantially all, of the geological structures or anomaly from the surface to the base of the Mississippian formation.

5. Said Unit Agreement and the unitized operation and management of the Unit Area will be in the interest of conservation and the prevention of waste, and that it will protect the correlative rights of all parties concerned.

WHEREFORE, Yates Petroleum Corporation requests that this application be set for hearing before an Examiner of the Oil Conservation Division on April 21, 2005, that notice be given as required by law and the rules of the Division, and that the Chicken Little State Exploratory Unit be approved.
