
As to your request for information, please find enclosed the following:

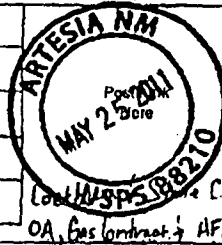
