Dear Jim:

As you know, this firm represents Siana Oil and Gas LLC and Tom M. Ragsdale. Mr. Ragsdale is the owner of a working interest and an overriding royalty interest in each of the above wells operated by Mack Energy Corporation. As an operator of long standing in New Mexico, Mack Energy Corporation is no doubt aware of its statutory obligations to pay interest owners under the Oil and Gas Proceeds Payments Act, NMSA 1978 ss 70-10-1, et seq.

Since September 29, 2011, Mack Energy Corporation has failed to pay Mr. Ragsdale for his proportionate share of production proceeds from the wells. However, from a review of publicly available records, both of these wells have continued to produce. Mr. Ragsdale has executed proper division orders for his interests in the wells, but no explanation for the discontinuation of payments has been provided. Further, we are aware of the existence of no other circumstances excusing payment under §§ 70-10-5 A through B.

On behalf of Mr. Ragsdale, please communicate to Mack Energy Corporation our demand that Mr. Ragsdale's interests be reinstated for pay and that payment for past amounts due be made immediately, plus interest for past periods as provided in §§ 70-10-5.
