STATEMENT OF THE CASE

APPLICANT:

RB Operating Company ("RB") applies to the New Mexico Oil Conservation Division for an order granting an exception to Rule 303.A and, in accordance with Rule 303.B and approving a centralized facility with a common tank battery including surface commingling and off-lease storage and measurement of oil production for its Brantley Tank Battery for the following described wells/leases with diverse ownership with the SW/4 and the S/2SE/4 of Section 23 and the N/2NE/4 of Section 26, T23S, R28E:

which shall be stored and measured at its centralized facility located in Unit N of Section 23. The applicant further seeks the adoption of an Administrative procedure for the expansion of this facility including the addition of other wells and production from other pools.

1.RB Operating is the operator of the above-described wells being produced from the East Loving Brushy Canyon Pool.

2. RB Operating also will operate a centralized facility with the common tank battery located in SE/4SW/4 (Unit N) of Section 23, T23S, R28E for the gathering of oil production from all these wells.

3. Effective April 1, 2003, See Order R-11972, Division Rule303.B (4) provided:

"Specific Requirements and Provisions for Commingling of leases, Pool or Leases and Pools with Diverse Ownership. (a) Measurement and Allocation Methods. Where there is diversity of ownership between two or more leases, two or more pools, or between different pools and leases, the surface commingling of production there from shall be permitted only if production from each of such pools or leases is accurately metered, or determined by other methods specifically approved by the Division, prior to such commingling."

4. RB Operating seeks approval to establish a measurement and allocation method for this production.

5. Any production for a designated gas pool will continue to be separately and continually metered in accordance with Division rules.

6. RB Operating also seeks an administrative procedure for the expansion of this project in order to add addition wells and /or pools.

7. As a result of different ownership among the spacing units for the wells within the SW/4 and S/2SE/4 of 23 Section and the N/2NE/4 of Section 26, the owners of the proposed commingled production is not identical in terms of parties or interest.

8. In accordance with Division Rule 1207.A and Rule 303.B(d) applicant has sent a copy of this application and notice for hearing to be held on April 21, 2005 to all the proper parties entitled to said notice.
