

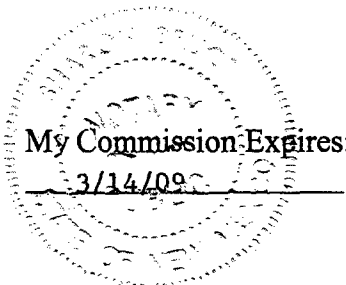


Ladies and gentlemen:

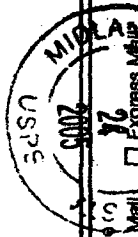
