
In accordance with Section 10 of the Poker Lake Unit Agreement dated March 18, 1952, Bass Enterprises Production Co., Operator of the referenced unit, hereby submits a Plan of Development for the Poker Lake Unit for the year 1996.

HISTORY OF PAST DEVELOPMENT

We refer to our previous Plans of Development for a detailed description of the operations conducted in this Unit in prior years.

1995 ACTIVITY

<u>Poker Lake Unit Well No 86</u> - This well was drilled at a location being 1,980' FSL & 660' FWL, Section 19, T24S-R31E, Eddy County, New Mexico. This well was drilled to a total depth of 8,825' and completed as an oil well in the Delaware formation in the intervals 7,870' - 7,885'. This well will be submitted during the calendar year 1996, for commercial determination and a participating area.

<u>Poker Lake Unit Well No. 92</u> - This well was drilled at a location 1,980' FSL and 660' FEL, Section 24, T24S-R30E, Eddy County, New Mexico. The well was drilled to a total depth of 8,224' and completed as an oil well in the Delaware formation from perforations 7,865' - 7,880'. This will be submitted during the calendar year 1996, for commercial determination and a participating area.

<u>Poker Lake Unit Well No. 105</u> - This well was drilled at a location being 660' FNL & 1,980' FEL, Section 36, T24S-R30E, Eddy County, New Mexico. This well was drilled to a total depth of 8,150' and completed as an oil well in the Delaware formation in the intervals 7,865' - 7,880'. This well will be submitted during the calendar year 1996, for commercial determination and a participating area.

<u>Poker Lake Unit Well No. 108</u> - This well was drilled at a location being 1,980' FSL & 1,980' FEL, Section 25, T24S-R30E, Eddy County, New Mexico. This well was drilled to a total depth of 8,150' and completed as an oil well in the Delaware formation in the intervals 7,855' - 8,014'. This well will be submitted during the calendar year 1996, for commercial determination and a participating area.

Poker Lake Unit Well No. 111 - This well was drilled at a location 660' FSL and 1,980' FEL, Section 25, T24S-R30E, Eddy County, New Mexico. This well was drilled to a total depth of 8,158' and completed as an oil well in the Delaware formation in the intervals 7,807' - 8,013'. This well will be submitted during the calendar year 1996, for commercial determination and a participating area.

<u>Poker Lake Unit Well No. 114</u> - This well was drilled at a location being 1,980' FNL & 2,080' FWL, Section 36, T24S-R30E, Eddy County, New Mexico. This well was drilled to a total depth of 8,174' and completed as an oil well in the Delaware formation in the intervals 6,677' - 6,823'. This well will be submitted during the calendar year 1996, for commercial determination and a participating area.

<u>Poker Lake Unit Well No. 123</u> - This well was drilled at a location being 1,980 FSL & 1,980' FWL, Section 22, T24S-R31E, Eddy County, New Mexico. This well was drilled to a total depth of 15,410' and is presently being evaluated after casing was set to total depth.

<u>Poker Lake Unit Well No. 93</u> - This well will be drilled at a legal location being 660' FEL & 1,980' FNL of Section 24, T24S-R30E, Eddy County, New Mexico to a proposed depth of 8,200' to test the Delaware Formation.

<u>Poker Lake Unit Well No. 115</u> - This well will be drilled at a legal location being 1,980' FWL & 660' FNL of Section 36, T24S-R30E, Eddy County, New Mexico to a proposed depth of 8,150' to test the Lower Brushy Canyon formation.

OFFSET OBLIGATIONS

Appropriate and adequate measures will be taken to prevent drainage of unitized substances from lands covered by the Poker Lake Unit Agreement or pursuant to applicable regulations.

MODIFICATIONS

In accordance with the terms and provisions of the Poker Lake Unit Agreement, this Plan of Development may be modified from time to time as a result of changing conditions.




