Gentlemen:

In accordance with Section 10 of the Poker Lake Unit Agreement, Perry R. Bass, as Operator, hereby submits for your approval a Plan of Development for 1981.

History of Past Development

We refer to our previous Plan of Development for a detailed description of this Unit.

1980 Activity

Poker Lake #49 - This well is currently drilling at a location of 1980' FNL and 990' FWL, Section 17, T24S-R30E to a proposed depth of 15,000' to test the Morrow Formation. Inasmuch as this well

will not reach total depth until the year 1981, the results of this well will be shown in the 1982 Plan of Development.

Plker Lake #50 - This well was drilled at a location of 660' FNL and 1980' FEL, Section 4, T25S-R31E, Eddy County, New Mexico. The well was drilled to a depth of 15,356' and is currently being tested. The results of this well will be shown in the 1982 Plan of Development.

Future Development

Poker Lake #51 - Section 9, T25S-R30E - 3,825' Delaware Test.

Poker Lake #52 - Section 10, T24S-R30E - 15,250' Morrow Test.

Poker Lake #53 - Section 20, T25S-R31E - 16,000' Morrow Test.

Additional Development

This Plan of Development shall constitute the drilling obligations of the Unit Operator under the terms of the Poker Lake Unit Agreement for period ending December 31, 1981. However, due to problems in obtaining drilling rigs, drilling problems, etc. which may be encountered, the actual drilling of one or more of these wells may encroach into the year 1982.

Offset Obligations

Appropriate and adequate measures will be taken to prevent drainage of unitized substances from lands subject to the Poker Lake Unit Agreement or pursuant to applicable regulations, fair

and reasonable compensatory royalty will be paid as provided by the Unit Agreement.

<u>Modifications</u>

It is understood that this Plan of Development may be modified from time to time to meet changing conditions.

Effective Date

This Plan of Development shall be effective January 1, 1981.
