



Gentlemen:

In compliance with Section 10 of the Poker Lake Unit Agreement, dated July 16, 1952, Perry R. Bass, as Unit Operator, hereby submits for your approval a Plan of Development for 1977.

#### History of Development

The past development of this Unit has consisted of 43 wells drilled to test unitized substances within the boundaries of the Unit.

Poker Lake Unit #42 was connected to Natural Gas Pipeline of America with deliveries commencing August 19, 1976.


Poker Lake Unit #43, located 660' FS&WL of Section 21, T-24-S, R-31-E, was plugged and abandoned on January 4, 1976 as a dry hole.

Poker Lake Unit #44, located 1980' FNL and 2180' FEL of Section 10, T-25-S, R-30-E, was spudded on January 5, 1976, with production casing run to T.D. The well is presently temporarily abandoned after extensive testing.

#### Future Development

Approximately 20 miles of detail seismic has been conducted this year within the boundaries of the Poker Lake Unit. We are presently reviewing this seismic in hopes of selecting a location for the drilling of a well to test unitized substances. We also plan to drill a well to test unitized substances to be located 660' FN&EL of Section 31, T-24-S, R-31-E.


