In compliance with Section 10 of the Poker Lake Unit Agreement, dated July 16, 1952, Perry R. Bass, as Unit Operator, hereby submits for your approval a Plan of Development for 1970.

HISTORY OF PAST DEVELOPMENT

The past development on this unit has consisted of four deep wells drilled to a depth of 13,500' or below. In addition to the four deep tests thirty-four shallow wells have been drilled to develop Delaware or Lower Delaware production.

Poker Lake Unit Well No. 37 was drilled to a total depth of 3,740' and the well produced from 7-10 barrels of oil and several barrels of water for several months in 1968 and was finally temporarily abandoned February 17, 1969. Poker Lake Unit Well No. 38 was drilled this year to a total depth of 3,682' and at this time, casing has been run and they are attempting to complete this well as a commercial producer. The location of this unit well is in the NE/4 NE/4 Section 19, T-25-S, R-30-E.

FUTURE DEVELOPMENT

Depending upon the outcome of Poker Lake Unit No. 38, additional development in this area is pending, however, initial tests indicate that possibly additional wells will be drilled. We also have plans to drill a 7,000' Lower Delaware test in Section 20, T-24-S, R-31-E. We have not consumated our deal on this well, however, a supplemental plan will be filed if such is indicated to be appropriate.

ADDITIONAL DEVELOPMENT

This plan of Development shall constitute the drilling obligations of the Unit Operator under the terms of the Poker Lake Unit Agreement ending December 31, 1970. Before this plan expires, a subsequent Plan of Development will be forwarded for your approval.

MODIFICATION

It is understood that this Plan of Development shall be effective as of January 1, 1970. If this Plan meets with your approval, please indicate in the appropriate space and return one copy for our files.
