Applicant in the above-styled cause seeks an order pooling all mineral interests in all formations from the surface to the top of the Precambrian Basement in the following described standard 640-acre spacing and proration unit comprised of all of Section 19, Township 19 North, Range 33 East, N.M.P.M., Harding County, New Mexico, which includes but is not necessarily limited to the Tubb formation (from the base of the Cimarron

Anhydrite to the top of the Granite), in the Bravo Dome Carbon Dioxide Gas Pool.
