NOW, on this 7th day of July, 2005, the Division Director, having considered the record and the recommendations of the Examiner,

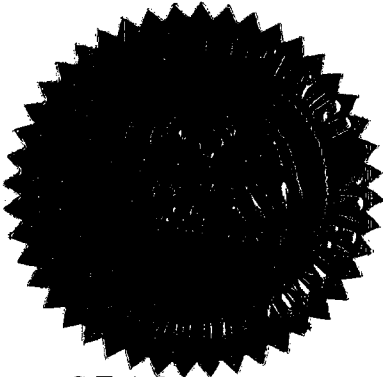
FINDS THAT:

3 EXAMINER JONES: Okay, let's go on the record and
4 call Examiner Hearing Docket Number 20-05. This is June
5 the 30th, 2005.

6 And let's call the continuances and dismissals.

7 On page 1, Case 13,502 is continued to July 14th;


