Heritage Petroleum, Inc., requests that the following documents be produced by the Jicarilla Apache Nation for inspection and copying at the offices of Montgomery & Andrews, P.A., 325 Paseo de Peralta, Santa Fe, New Mexico 87501, twenty (20) days after service of this request.

REQUEST NO. 1: All documents relating to the acquisitions by the Jicarilla Apache Nation of the surface and of the fractional mineral interest in the Theis Ranch lands in 1985.

REQUEST NO. 2: All documents relating to any acquisitions by the Jicarilla Apache Nation of any mineral interests in the Theis Ranch lands subsequent to 1985.

REQUEST NO. 3: All documents relating to any application by the Jicarilla Apache Nation pursuant to 25 CFR Part 151 for approval of the conveyances in 1987 of the surface and of the fractional mineral interest in the Theis Ranch lands.

REQUEST NO. 4: All documents relating to any applications by the Jicarilla Apache Nation pursuant to 25 CFR Part 151 subsequent to 1987 relating to any other interest in the Theis Ranch lands.

REQUEST NO. 5: Any supporting materials, including any business plans, relating to the matters described in paragraphs 3 and 4, above.

REQUEST NO. 6: All preliminary, final or supplemental title opinions for the Theis Ranch lands, including the March 3, 1988 Office of Field Solicitor's Final Title Opinion, along with documentation of the satisfaction or waiver of any title curative requirements set forth therein.

REQUEST NO. 7: All documents relating to the Tribe's acknowledgement that the exceptions and reservations noted in the title binder for the Theis Ranch will not interfere with the Tribe's contemplated use of the land, as referenced in that Memorandum dated July 14, 2006 from Lynn A. Johnson, Acting Regional Solicitor, to Larry Morrin, Regional Director, BIA Southwest Region.

REQUEST NO. 8: All documentation of any application or request of the Jicarilla Apache

Nation to the Secretary of the Department of Interior or his delegated representatives that any
part of or interests in the Theis Ranch lands be placed into reservation status.

REQUEST NO. 9: Documents relating to any notification of the State of New Mexico and Rio Arriba County of the Jicarilla Apache Nation's applications pursuant to 25 CFR Part 151 or otherwise to place the surface and any fractional mineral interest in the Theis Ranch lands into trust status or reservation status.

REQUEST NO. 10: Documents relating to any notification of the owners of any mineral interests or oil and gas leases of the Jicarilla Apache Nation's applications pursuant to 25 CFR Part 151 or otherwise to place the surface and any fractional mineral interest in the Theis Ranch lands into trust status or reservation status.

REQUEST NO. 11: Documents evidencing whether any interests in the Theis Ranch lands were set aside for tribal use.

REQUEST NO. 12: All documents responsive to the Jicarilla Apache Nation's Written Request for Issuance of Subpoenas dated August 30, 2012 in NMOCD Case No. 14904.
