

The units are to be dedicated to the Marra Well No. 1, to be re-entered in the NE4NW/4 of Section 14. Also to be considered will be the cost of re-entering and completing the well, and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Guardian Operating Corp. as operator of the well, and a 200% charge for the risk involved in re-entering and completing the well. The application is scheduled to be heard at 8:15 a.m. on Thursday, November 29, 2012 at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505.
