

Case No. 14970:

***Application of Devon Energy Production Company, L.P. for special rules and regulations for the Scanlon Draw-Bone Spring Pool, Turkey Track-Bone Spring Pool, and Winchester-Bone Spring Pool, Eddy County, New Mexico.*** Applicant seeks an order establishing special rules and regulations for the Scanlon Draw-Bone Spring Pool, Turkey Track-Bone Spring Pool, and Winchester-Bone Spring Pool, including a gas:oil ratio of 10,000 cubic feet of gas for each barrel of oil produced. The Scanlon Draw-Bone Spring Pool includes part of Section 19, Township 19 South, Range 29 East, NMPM; the Turkey Track-Bone Spring Pool includes parts of Sections 26 and 29, Township 19 South, Range 29 East, NMPM; and the Winchester-Bone Spring Pool includes part of Section 36, Township 19 South, Range 28 East, NMPM, parts of Sections 31 and 32, Township 19 South, Range 29 East, NMPM, and part of Section 5, Township 20 South, Range 29 East, NMPM. The Scanlon Draw-Bone Spring Pool is centered 15 miles east-northeast of Lakewood, New Mexico; the Turkey Track-Bone Spring Pool is centered approximately 17-1/2 miles east of Lakewood, New Mexico; and the Winchester-Bone Spring Pool is centered approximately 15 miles east-southeast of Lakewood, New Mexico.

APPLICATION

Devon Energy Production Company, L.P. applies for an order establishing special rules and regulations for the Scanlon Draw-Bone Spring Pool, Turkey Track-Bone Spring Pool, and Winchester-Bone Spring Pool, and in support thereof, states:

1. Applicant is an operator in the Scanlon Draw-Bone Spring Pool, Turkey Track-Bone Spring Pool, and Winchester-Bone Spring Pool.

2. The Scanlon Draw-Bone Spring Pool was created by Division Order No. R-9326, and currently includes the following acreage:

Township 19 South, Range 29 East, N.M.P.M.  
Section 19: NE/4

3. The Turkey Track-Bone Spring Pool was created by Division Order No. R-8827, and currently includes the following acreage:

Township 19 South, Range 29 East, N.M.P.M.  
Section 26: E/2  
Section 29: SW/4

4. The Winchester-Bone Spring Pool was created by Division Order No. R-6476, and currently includes the following acreage:

Township 19 South, Range 28 East, N.M.P.M.  
Section 36: N/2

Township 19 South, Range 29 East, N.M.P.M.

Section 31: NW/4 and S/2

Section 32: W/2

Township 20 South, Range 29 East, N.M.P.M.

Section 5: NW/4

5. Applicant requests that special rules and regulations be established for the above three pools, providing for:


(a) A limiting gas:oil ratio of 10,000 cubic feet of gas per barrel of oil, based on the top oil allowable in each pool; and

(b) All other rules be in conformance with statewide rules.

6. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

**WHEREFORE**, applicant requests that, after notice and hearing, the Division grant the relief requested above.
