CLOSING ARGUMENTS OF JALAPENO CORPORATION

The Closing Arguments of Jalapeno Corporation are as follows:

The testimony of the witnesses listed in the table on the following page has been an education about the properties of bentonite clay and the processes of evapotranspiration and of salt movement, accumulation and precipitation and how they work from the vegetation on soil cover, the four foot of soil cover over the pit or trench and the bentonite clay in the drilling mud entombing constituents to the "salt bulge" to protect public health and the environment as shown in the table on the following page.
