Applicant further seeks the pooling of all mineral interests (i) in the Delaware formation underlying the E/2 E/2 of Section 13 to form a non-standard 160 acre oil spacing and proration unit (project area), and (ii) from the surface to the base of the Bone Spring formation underlying the NE/4 NE/4 of Section 13, for any formations and/or pools developed on 40 acre spacing within that vertical extent. Applicant further seeks the pooling of all mineral interests in the Delaware formation underlying the non-standard oil spacing and proration unit (project area). The unit is to be dedicated to the Harroun Trust 31 Well No. 3H, a horizontal well to be drilled at a surface location in the SE/4SW/4 of Section 31, with a terminus in the NE/4SW/4 of Section 30. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The unit is located approximately 1 mile northwest of Harroun, New Mexico.

 - Application of Devon Energy Production Company, L.P. to Re-open Case No. 14936 to amend the special rules and regulations for the Northwest Fenton-Delaware Pool, Eddy County, New Mexico. Applicant seeks an order amending the temporary special rules and regulations for Northwest Fenton-Delaware Pool to provide for a special depth bracket allowable of 300 barrels of oil per day for a standard 40 acre oil spacing and proration unit, effective as of November 1, 2012.
