We did get about 300 gallons of diesel, which puts the weight of the tank above the weight limit of our skidsteer loader. Consequently, I wouldn't be able to move it with our current equipment. That being said, perhaps Cyrq could send over a forklift or crane from their arsenal of equipment.

This being said, I don't want to move the tank if Cyrq isn't going to do the remediation system to completion. Moving it is a pain and I like where it is, save and except the treatment system goes in.

FYI, the water is still bright green.
