Richard,

Jim can correct any misstatements on my part, but Nadel & Gussman are prepared to present the rest of their case on Thursday, however, DHA and Arrington Oil and Gas have requested that this matter be continued. The parties have been actively negotiating all along and believe that they can work out an agreement but cannot do so by the hearing on the 29th. In fact, because of the issues involved, DHA and Arrington Oil and Gas have requested that the case be continued until the January 10th hearing docket. That time frame will provide sufficient time for the parties to get the work done necessary to reach agreement.

Nadel and Gussman, I believe, already have continued this case three times. DHA and Arrington Oil and Gas requested and was granted the last continuance in this matter at the previous hearing. Negotiations have been continuing since that hearing, but the parties require more time to work out the issues.

My understanding of the continuance policy is that no party can use more than three continuances. Here, Nadel and Gussman have used their three and are prepared to finish presenting their case, but DHA and Arrington Oil and Gas are requesting their second continuance in this matter to reach agreement. Nadel and Gussman do not oppose the continuance because the parties believe it will result in voluntary agreement.
