Reference is made to that certain letter dated May 1, 2013 to you from EOG Resources, Inc. (hereafter "EOG") where EOG offered to lease your mineral interest in the captioned land or, in the alternative, for you to participate in the drilling of the proposed captioned well. To date we have not received a response from you regarding either proposal.

The purpose of this letter is to advise you that EOG has re-staked the surface hole location for said well to a point 2,422' FNL and 422' FEL of Section 27, T26S, R33E, N.M.P.M., Lea County, New Mexico in order to avoid encroachment on a contiguous lease.

Objective formation, estimated bottom hole location, estimated length of treated lateral and estimated TVD have not changed.


